If there is a black rainstorm warning or a tropical cyclone warning signal number 8 or above in force in Hong Kong or a red rainstorm warning or a red typhoon warning signal in force in Shenzhen at or after 6:00 a.m. on 28 June 2019 and/or the Hong Kong or Shenzhen Observatory has announced at or before 6:00 a.m. on 28 June 2019 that either of the abovementioned warnings is to be issued within the next two hours, the AGM shall automatically be postponed to 3 July 2019 (the "Re-scheduled Day") on which no black rainstorm warning or tropical cyclone warning signal number 8 or above (in case for Hong Kong) or no red rainstorm warning or red typhoon warning signal (in case for Shenzhen) is hoisted on the Re-scheduled Day and in such case the meeting shall be held at 10:15 a.m. at Conference Room, 4/F., Chuangjian Building, No. 6023 Shennan Road, Futian District, Shenzhen, China.
